## Parking Permit Rules & Regulations

---

All parking permits (sticker permits) must be properly displayed while parked at the UC Merced Campus. The permit must be clearly visible of all tint, or dash board, placed in the lower left hand corner of the front windshield. Failure to display your sticker permit will result with a citation.

All hanging permits must be face-up, hanging off the rear view mirror, or face-up on the dash board. Failure to display this permit properly may result with a citation.

Your parking permit must be updated with the most current information. If you need to add any other vehicles, you may do so by emailing taps, taps@ucmerced.edu.

As a UC Merced permit holder, you are entitled to a copy of these rules and regulations by visiting the TAPS website: taps.ucmerced.edu.

You must park in the designated parking lots associated with your permit type. Failure to park in the designated lot will result with a citation.

It is your responsibility to ensure that you are correctly displaying your current parking permit and parking in a designated parking space in the correct parking lot.

### Altered and Stolen Permits
