California Vehicle Code 40215(6) requires that the person requesting an administrative hearing deposit the amount of the parking penalty at the time the Administrative Hearing is requested. If the citation is dismissed, a refund will be issued.

<p>A personal conference requires the following:</p> <ol style="list-style-type: none">1. The requestor must complete the form entitled REQUEST FOR ADMINISTRATIVE HEARING.2. These two forms must be received by Transportation and Parking Services by the close of business on the 21st calendar day from the mailing date on the Administrative Review Level 1 Determination Letter.3. The administrative hearing deposit in the amount of the original parking penalty must be paid in full at the time the forms are submitted to Transportation and Parking Services. Cash, check, money order and cashier's checks are accepted. <p>The personal conference will be scheduled within 90 days of the request date. The requestor will be notified via U.S. mail as to the date, time and location of the hearing. The requestor has the right to reschedule the hearing one time by contacting Transportation and Parking Services 72 hours before the scheduled hearing time.
