North Bowl Solar Carport Project

Technical Specifications

- One of the largest single-carport systems in the region.
- Maximum power output of 4.2 MW (8,000 MWH/year = 570 average houses)
- Includes up to 500 kW of battery storage.
- Provides 950 covered parking spaces
- Reopens fall 2018



Project 2020 Parking

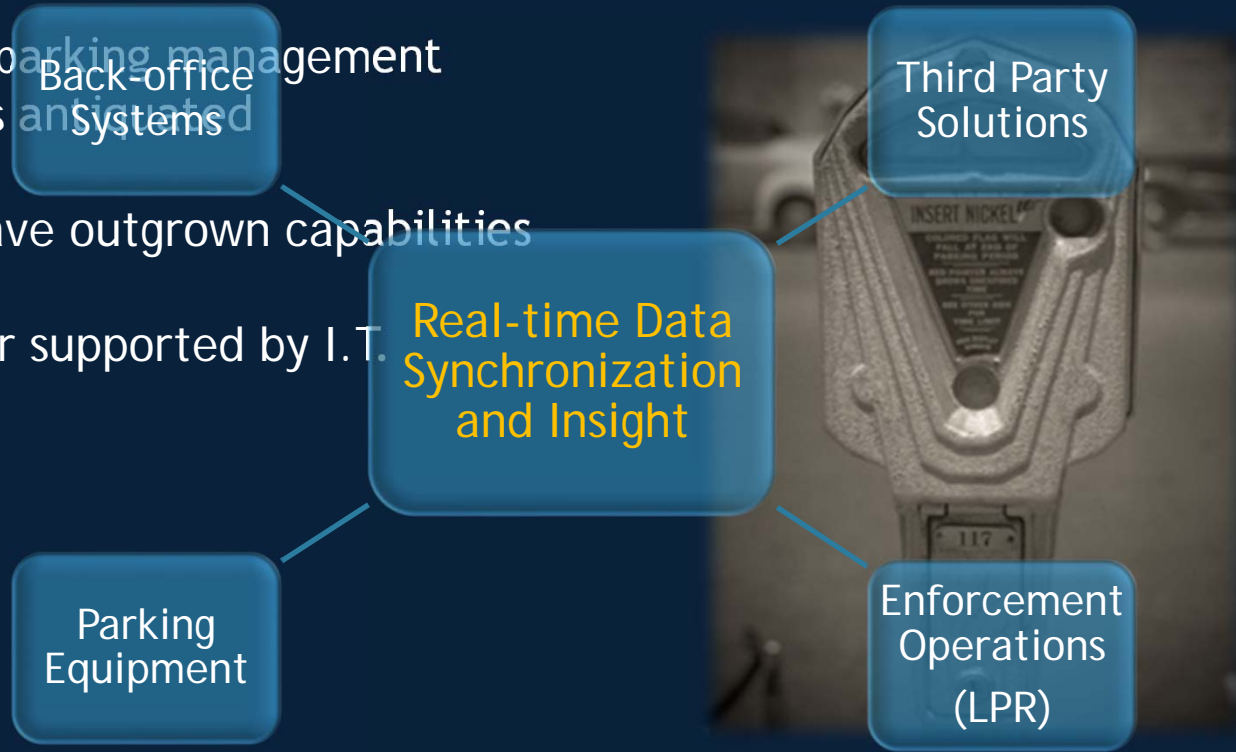
1. August 2018 - Scholars Lot (F/S/Visitor parking; ~500spaces); possible site location for App based Rideshare (Uber/Lyft), or on campus resident parking
2. November 2018 - Bellevue Lot 2nd Delivery (~400+ spaces; commuter student, accessible parking, EV charging
3. Spring 2020 - Bellevue Lot 3rd Delivery (~700 spaces; F/S/Visitor parking); possible location for App based Rideshare

Why the Change?

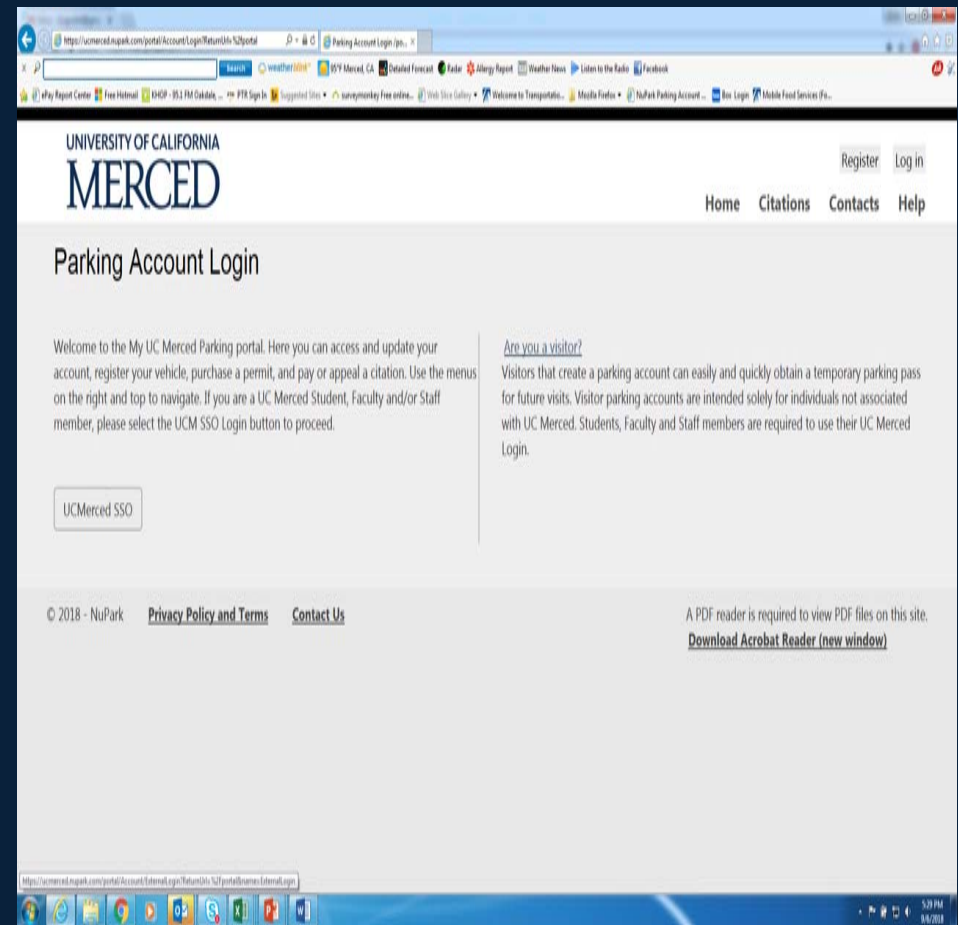
- Original parking management system is antiquated

- No longer supported by I.T.

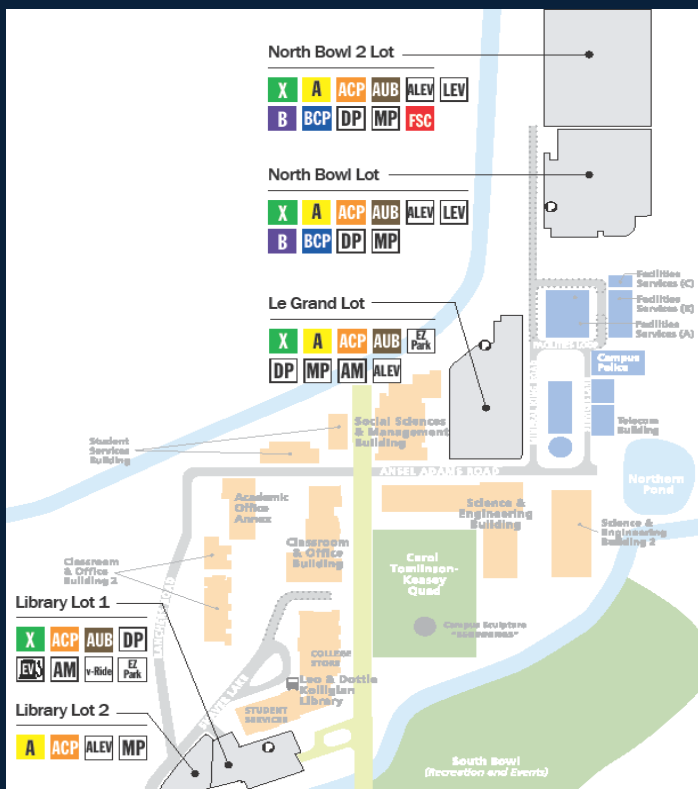

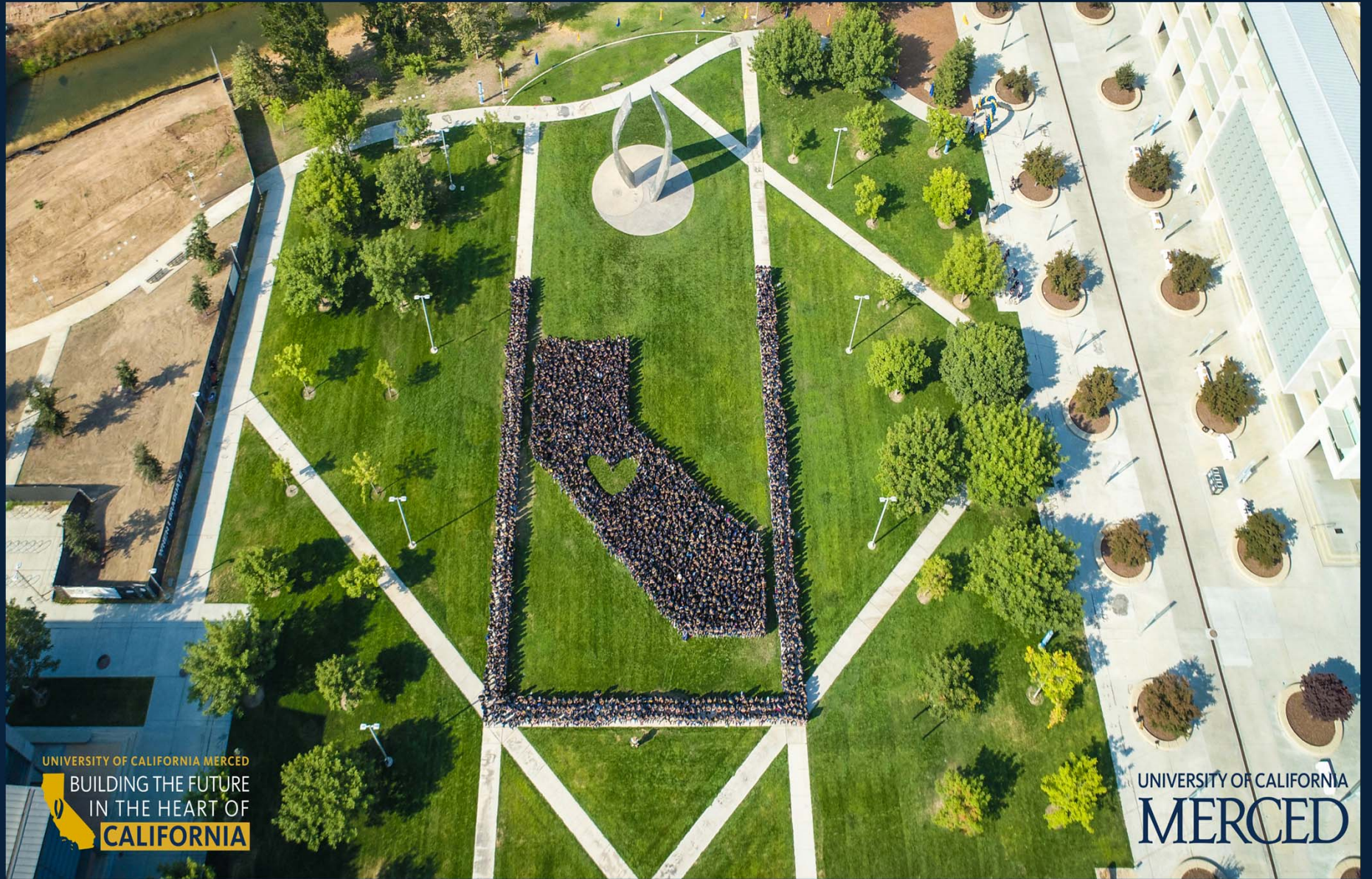

 - Point to point fixed transit
 - Peak hour service
